# Studio Policies, 2011-2012

Please read this information thoroughly.

## Registration and Payments

- ◆ With your registration, you are signing up for the **ENTIRE session**, or the remainder of the session, **(through week #40)**. This yearly tuition is divided into smaller more convenient payments that are due every tenth week. Or you can pay more frequently, every fifth week, for an additional \$2.00 fee.
- ◆ *Tuition will be charged to your account until you WITHDRAW using a withdrawal form. We must be notified in writing 2 weeks prior to your withdrawal date. **Those 2 weeks from notification are non-refundable.***
- ◆ Payment due dates are listed:
  - On the calendar at the studio
  - On signs posted on the bulletin boards at the studio
  - On the website: [www.dance-etc.com/news/duedates.aspx](http://www.dance-etc.com/news/duedates.aspx)
- ◆ Dance Etc. does not mail reminders. We can, however, e-mail them if you give us a valid e-mail address. Your e-mail address will not be shared with anyone.

## Fees

- ◆ There is a \$10.00 fee if payment is late.
- ◆ There is a \$25.00 fee for checks returned from the bank.

## Refunds

- ◆ Tuition is NOT PRO-RATED due to absences or holidays. Make-up classes can be arranged on a space available basis.
- ◆ NO REFUNDS will be issued for absences or no-shows. NO REFUNDS for snow days.
- ◆ We must be notified in writing 2 weeks prior to your withdrawal date. **Those 2 weeks from notification are non-refundable.**

## Spring Showcase and Costumes

- ◆ The \$75.00 fee for your Spring Showcase costume includes costume, participation fee (\$10.00) and administrative fee (\$10.00) as well as other expenses involved with your child's participation in the Showcase. The participation fee and administrative fee is due even if you provide your own costume. **Tickets to the Spring Showcases are not included.**
- ◆ We offer five separate recitals (shows) throughout the weekend. If your child(ren) are performing in more than one routine, there is a chance that you will be scheduled to participate in more than one show. Tickets will need to be purchased for all shows that you are attending.
- ◆ Costume fees are due by December 1. Payments made after this date will be charged a \$10.00 late order fee. Late costume orders may not be delivered in time for the costume rehearsal.
